- Public Meeting was held April 4 at First Baptist Church by NC Dept of Cultural Resources regarding impacts to New Hill Historic District and historic property. Meeting was well attended and our public comments will be summarized and submitted as part of Draft EIS
- Draft EIS response documents for Public Hearing complete hearing is mid May/early June timeframe
 - Still obtaining signatures on our Petition. It will be submitted to DENR
 - Tonight we will begin prepping volunteer speakers for the DENR public meeting estimating max 3 minutes each
- Will need DENR letter writing campaign for public comments. Sample letters will be available
- Legal update
 - Current date for court hearing is Tuesday May 30 at 10:30 AM in courtroom 10D. Defendant attorneys have been trying to delay hearing until July. They also submitted a motion to dismiss the case on various grounds. For example: NHCA is not incorporated in NC. NHCA expedited process to incorporate and did so on April 10
 - At last community meeting it was suggested looking into "amicus brief" from churches. Use church Proclamation sent to WWP. Might be as good as being a Plaintiff. Attorney advised us that this was not an option

New and Future Business

- Trying to arrange a meeting between NHCA and Wake County Delegation (elected officials).
 Community was asked to write letters or email our delegates (Sen. Stevens and Rep. Paul Stam) asking them to support our request for a meeting. Larry Elmore will draft a sample letter / email for folks to use and tailor to their own personality.
